Cross Registration Shooters that are interested may cross register their targets with ATA subject to all fees, rules and requirements of the ATA.

Note: Lewis Purse 3 Classes Pays 100%

In case of tie, all Class purses will be evenly split **except the event** top score will shoot off.

Payments: Checks and cash will be accepted

Awards: All prizes are belt buckles this year and they will be available in clubhouse very soon after the conclusion of an event **except** when there is a shoot off. No shooter may win more than one award per event.

Shoot-Offs: Shoot offs will be conducted after all events have concluded each day.

Notice: SRS Club Board reserves the right to modify or change this program

Ammunition: Reloads that meet PITA standards are permitted. Winchester, Remington and Federal factory loads are available at posted prices.

Note: All purses will be paid by check and mailed after the shoot is over.

Calcutta purse pays one place for less than 10 participants and two places for 11 or more.

Conduct: The SRS Club and Directors reserves the right to refuse entry or withdraw any contestant who in any way interferes with **safety, harmony or the enjoyment** of the shoot.

Refunds: No refunds will be given once an event has started.

New PITA Members can join 1/2 fee, PITA pays half.

Special Note:

Juniors may shoot this program for \$1 per event, plus state and daily fees provided they do not play any purse options and they will only qualify for Jr. trophies. They will pay full price if they play for any other trophies or options.

OSTA MAGNUM

The Magnum option is like the perfect 50's. It is only on a 100-target handicap event. There are six ways to win. Each 50 has its own purse, which are as follows:

Traps 1&2 - 1&3 - 1&4 - 2&3 - 2&4 - 3&4

The cost to play is \$12.00, which is \$2.00 per combination and all combinations, must be played. The payoff is 50% of the value of the 2-trap combination. A shooter can win more than one magnum per event. If more than one shooter wins the magnum they all split the 50% payoff. Since this is a state option in which all state PITA clubs participate in amounts are not known until the week of the shoot.

New Improvements.

Snake River Sportsmen received a grant from the Oregon Division of Wildlife to up grade our trap fields and equipment. The trap pads for fields 2 and 3 have been completely replaced with new concrete and two new Pat trap machines have been purchased and installed on these two fields. For this shoot, all fields will have automatic machines with Canterbury voice releases. We have done considerable work on the trap ranges to improve shooter conditions.
